# Just Group plc refinances £45 million term loan for Rocket Properties

- The five-year loan is secured against Rocket Properties' Provost & East and three retail elements of the Atlas Building in London
- The properties comprises 95,000 sq ft, primarily of Grade A office and leisure space

**Just Group** plc ("Just"), the FTSE 250 insurer, has completed a £45 million refinancing deal for Rocket Properties' signature developments in London. The transaction was originated by Rothschild & Co and completed in May 2025.

The five-year term loan is secured against Rocket Properties' Provost & East building in its entirety, and three retail units in the Atlas Building. Both are located near Old Street's 'Silicon Roundabout', London's leading technology hub. Provost & East is primarily an office-led asset with 86,000 square feet of office space, with additional leisure space all spread across 10 floors, while Atlas is a residential development that includes ground-floor retail units.

Provost & East is certified as BREEAM (Building Research Establishment Environmental Assessment Method) 'excellent' with an EPC rating of B. It forms part of Rocket Properties' collaboration with local communities to re-energise areas of London with innovative commercial and residential developments, with sustainability in mind.

The refinancing of Rocket Properties' signature buildings by Just demonstrates its ongoing commitment to directing institutional insurance capital towards sustainable assets and meeting its productive finance agenda.

Just is trusted to carefully look after around £28 billion of its customers' pension savings and has significant investments across real estate and social housing, with transactions originated through both Just's own internal investment team as well as external asset managers.
